This requirement means that your organization will no longer be able to conduct and bingo and/or raffle activities, except those that fall under 60-2B-13. (B.) and you must expend all monies from your existing Bingo and Raffle Operations Bank Account.

You are also required to complete and return the attached Release Authorization form to NMCGCB via mail or fax: 505 841-9725 Attention Raechelle Jacobo so we may forward it to the NM Taxation and Revenue Department. Along with closing your file with NMGCB, your Bingo & Raffle tax account also needs to be closed with NM Taxation and Revenue Department upon termination of your Bingo License so there are no penalties or interest accrued as a result of not communicating the termination of your bingo operations.

Please provide us with copies of the last bank statement from the Bingo Operating Account that reflects your organization's final bingo activity in 2008, along with imaged copies of the deposit slips and cancelled checks (front and back) so we are able to verify that your organization is in compliance with the above referenced requirement. We are requesting you submit these documents to the attention of NMGCB - Audit Division within 30 days from the date of this letter. If you fail to provide this information it may jeopardize your future ability to obtain a bingo and raffle license or a nonprofit gaming operator's license under the New Mexico Gaming Control Act.
